We then limit overall membership as well as subordinate caps based on the hunter's primary and secondary hunting interest compared to our current membership profile as well as our land profile. The objective is never to have too many of any one type of hunter. This allows each hunter to hunt on his schedule any time during any season across our three state region and do so without stepping over the boot prints of others or competing with the public lands hunter mentality.

They both spend time on the land year round, they both hunt, and they both know what the hunter needs in terms of the all to hard to get land resource.

Cost \$1,500 the first year. Dropping to \$1,200 the second.

One cost for access to all acreage in all three states for all seasons.

Memberships are a 365 day year from the date allocated the membership until that anniversary the next calendar year.

Lodging is available from an up to date Association yellow pages type listing for every county where the Association has hunting lease land.

The hunter provides his own licensing, transportation, equipment, meals.

The advantage of hunting through this Association is first private hunting land access. The next is the two Association partners, Jon Nee and John Wenzel, acting as friendly points of contact to assist the hunter. Third, is that the Association does not operate a lodge. Thereby the Association not limited to the driving distance around that lodge for land access. That allows the Association to make the entire state available to choose where to acquire land. In that regard when it comes to spending money, the Association does so where it gets the best return for its hunters. The final significant advantage is that this is entirely a self guided hunter organization.
